(2) All proposals must be received by the above named contact by 5:00 PM on the closing date of this RFP.

(3) Bid must clearly indicate **E-rate eligible/ineligible costs** in accordance with the latest E-rate modernization rules.

(4) All proposals must include vendors SPIN number.

(5) Preference shall be given to in-state vendors and to those that with a prior business experience. Final selection of the service provider is the responsibility of **Ness City Schools**. Once a selection has been made, **Ness City Schools** shall notify the provider in order to begin service implementation procedures.

The awarding of contracts resulting from this RFP is contingent upon E-rate funding from Schools and Libraries Division of the Universal Service Administration and/or USD 303 Board of Education approval.
